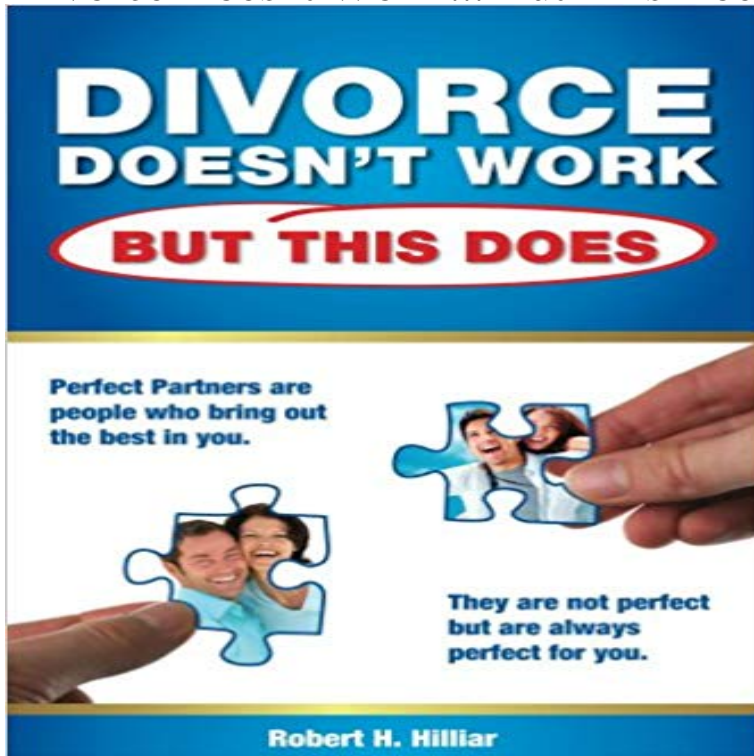


Divorce Doesn't Work ... But This Does
