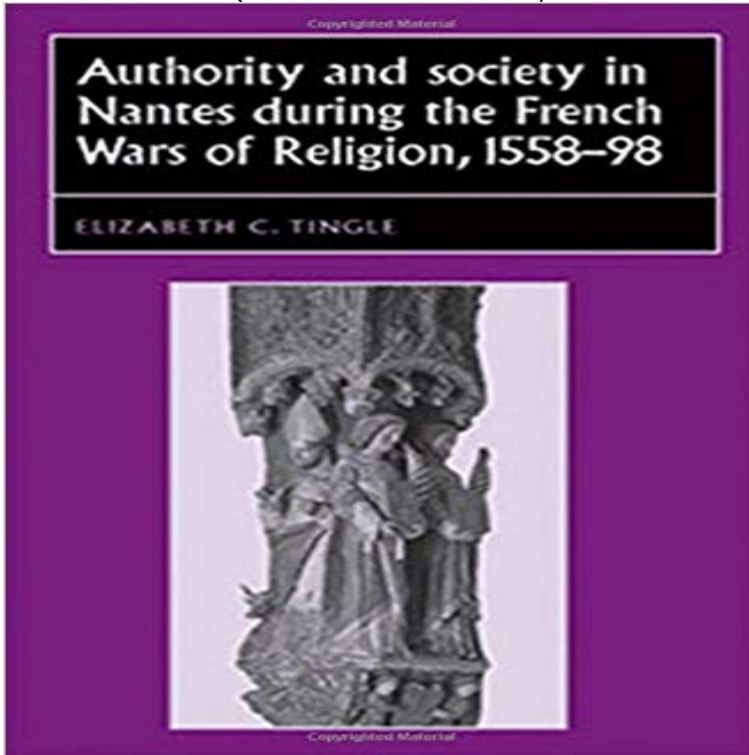


# Authority and Society in Nantes during the French Wars of Religion, 1559-1598 (Studies in Early Modern European History)
