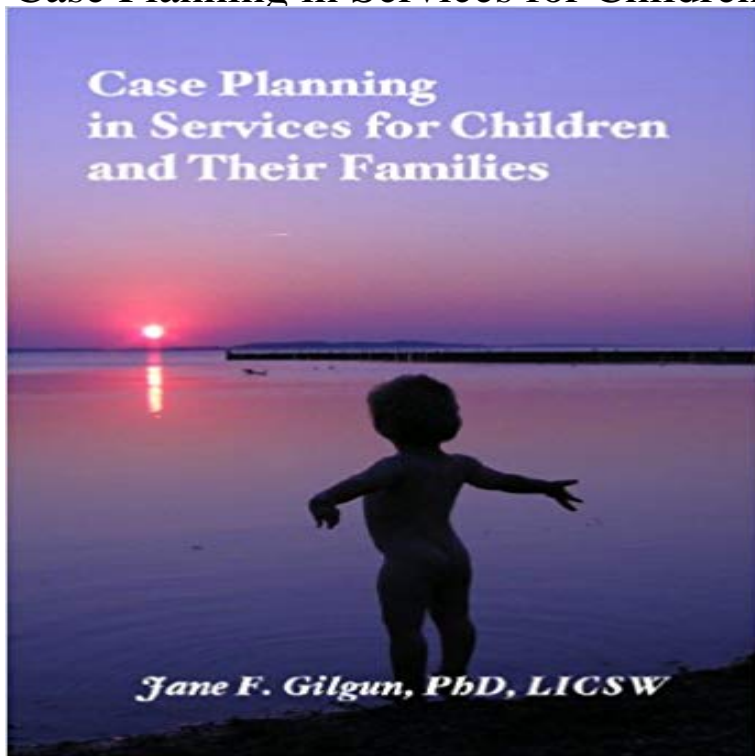


## Case Planning in Services for Children and their Families
