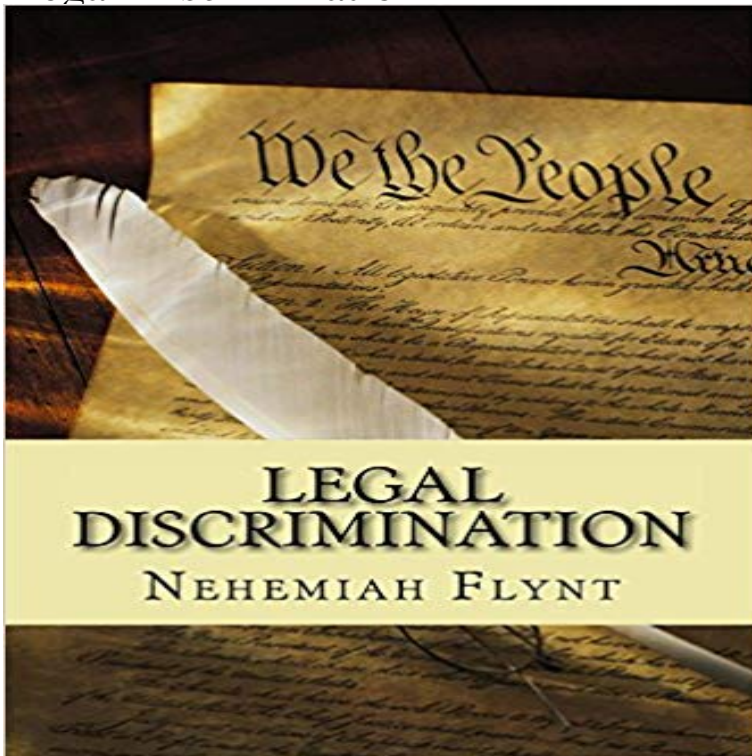


Legal Discrimination
