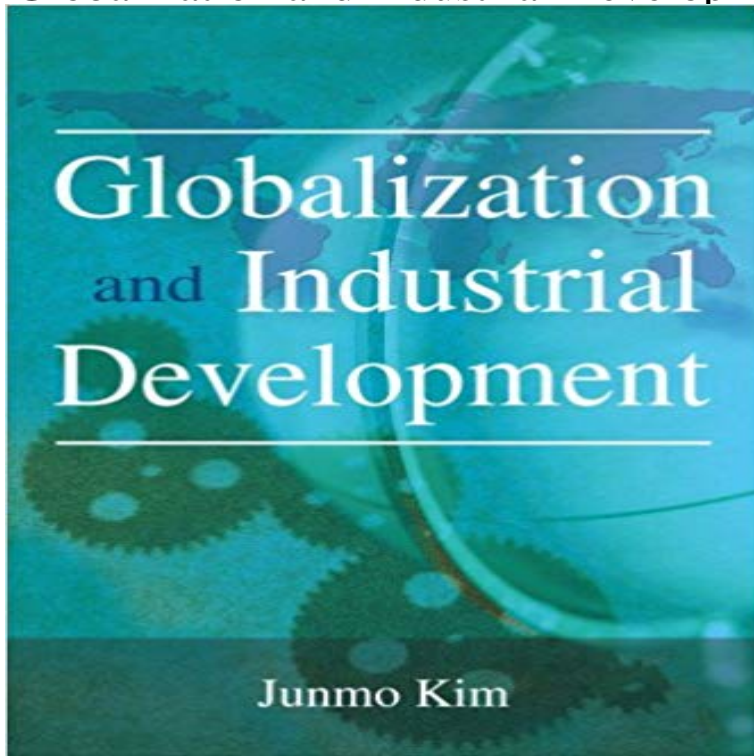


## Globalization and Industrial Development

Furthermore, an empirically based research in itself finds room for its own appeal when it can present a spectrum of different industrial and interests gaining and losing with the advent of economic integration. This book tackles this point. Especially, this book questions whether there has been a common economic dynamic that has driven the economic integration. If there is any common economic dynamic per se that has had major impact on globalization and integration, this book can present how different industrial sectors of different regions are affected, and thereby provide clues to fill the gaps in the existing theories.
