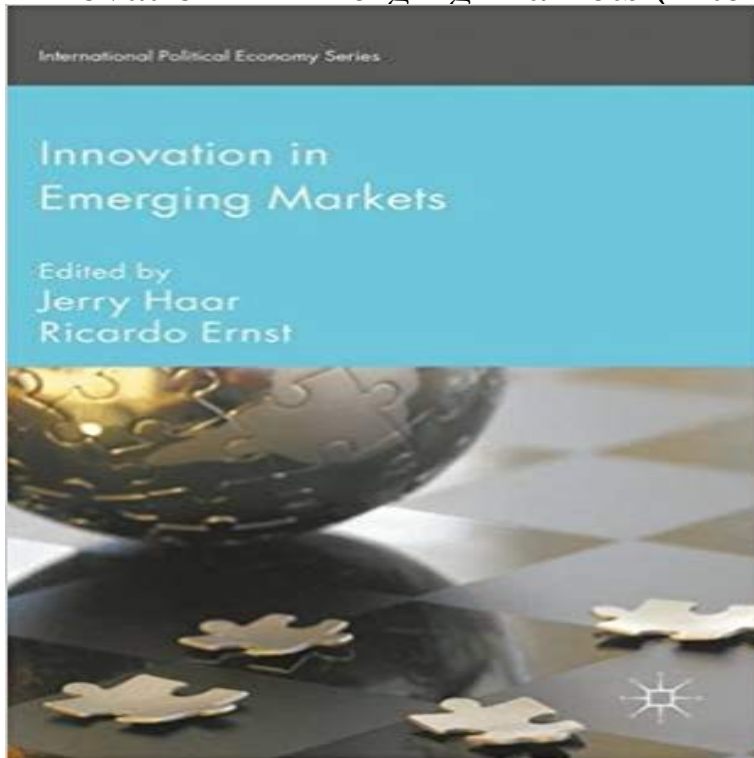


Innovation in Emerging Markets (International Political Economy Series)
