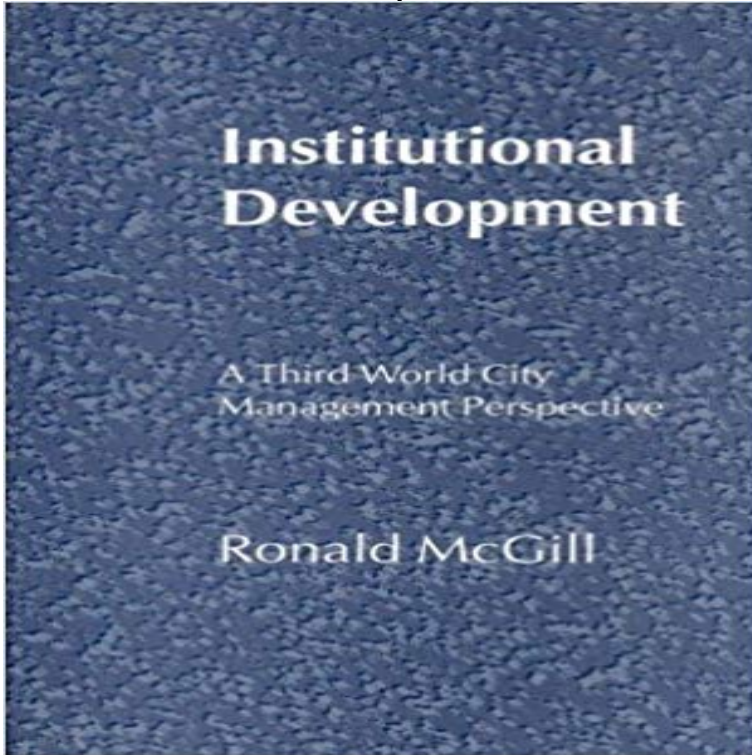


Institutional Development: A Third World City Management Perspective
