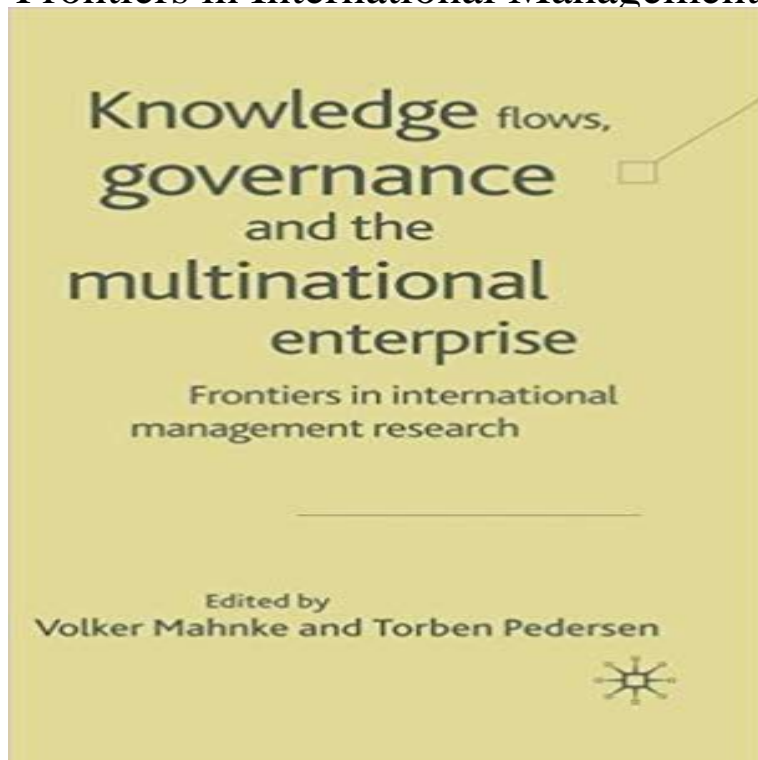


Knowledge Flows, Governance and the Multinational Enterprise: Frontiers in International Management Research
