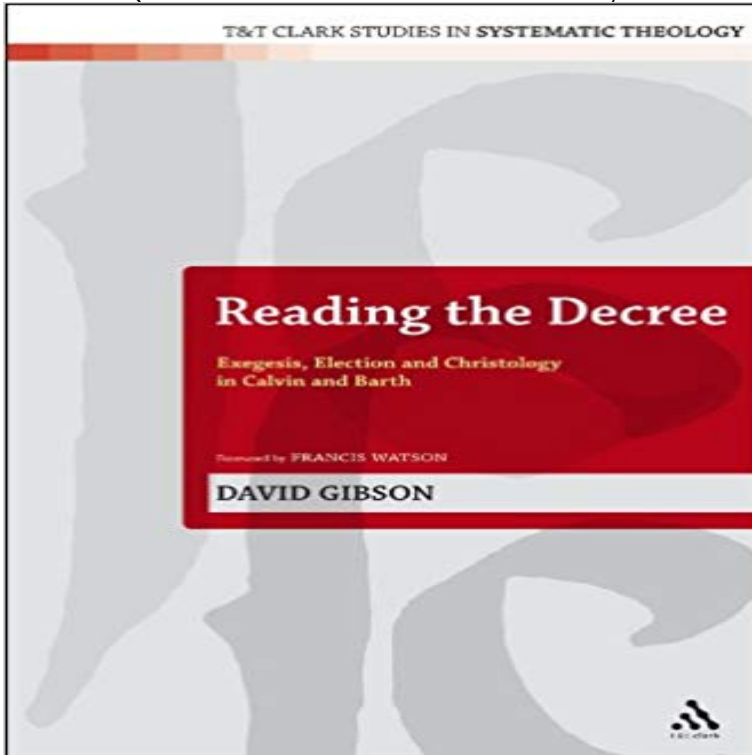


# Reading the Decree: Exegesis, Election and Christology in Calvin and Barth (T&T Clark Studies in Systematic Theology)



What role does the interpretation of Scripture play in theological construction? In *Reading the Decree* David Gibson examines the exegesis of election in John Calvin and Karl Barth, and considers the relationship between election and Christology in their thought. He argues that for both Calvin and Barth their doctrine of election and its exegetical moorings are christologically shaped, but in significantly different ways. Building on Richard A. Mullers conceptual distinction between Calvins soteriological christocentrism and Barths principal christocentrism, Gibson carefully explores their exegesis of the topics of Christ and election, and the election of Israel and the church. This distinction is then further developed by showing how it has a corresponding hermeneutical form: extensive christocentrism (Calvin) and intensive christocentrism (Barth).
