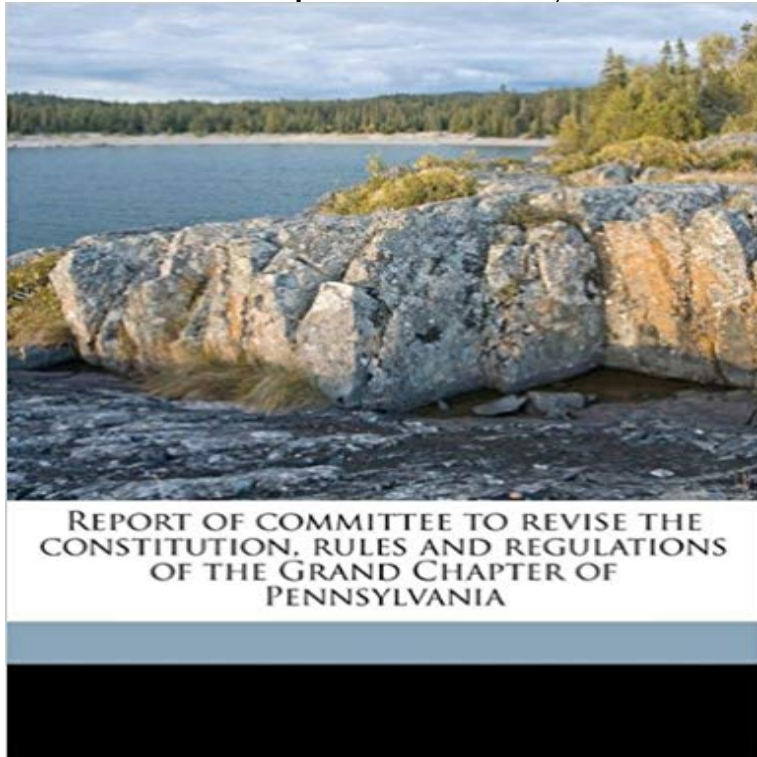


# Report of committee to revise the constitution, rules and regulations of the Grand Chapter of Pennsylvania
