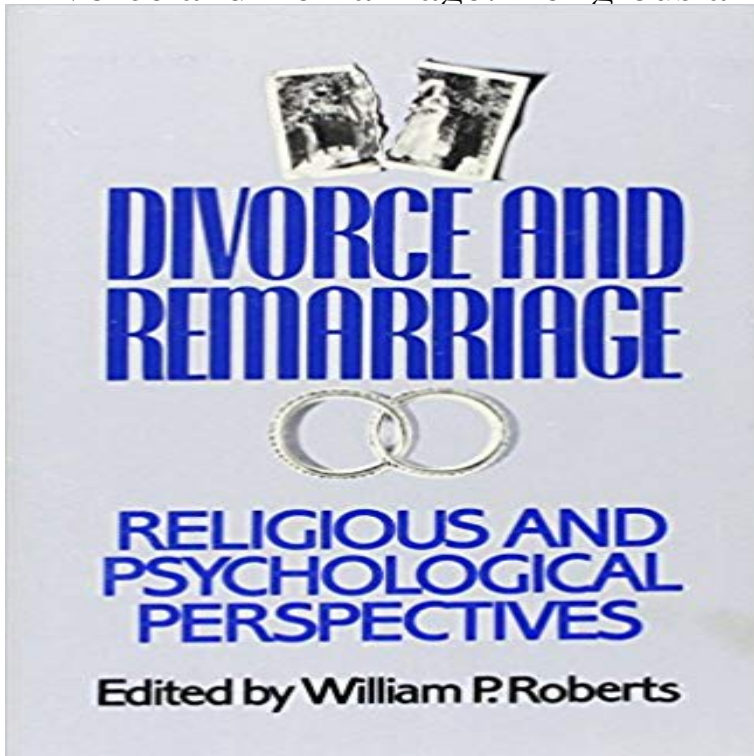


Divorce and Remarriage: Religious and Psychological Perspectives
