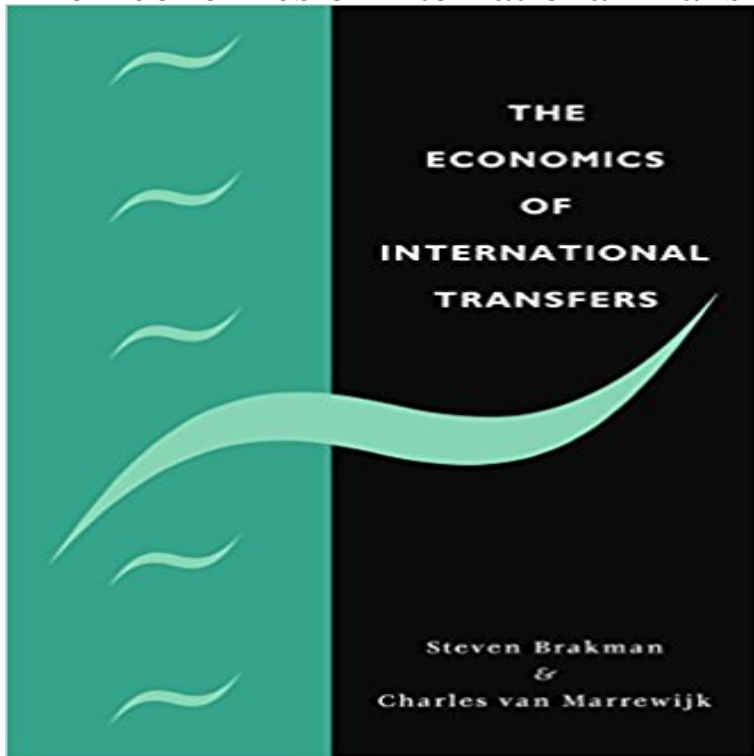


The Economics of International Transfers

Today the subject is of even greater importance, particularly for developing countries, with billions of dollars flowing between nations. In *The Economics of International Transfers* Brakman and van Marrewijk survey the history of the subject and provide an up-to-date framework for the modeling of transfers. Topics covered include welfare effects, distortions, third parties, rent-seeking, the trade or aid discussion, multi-lateral agencies, tied aid and imperfect competition.
