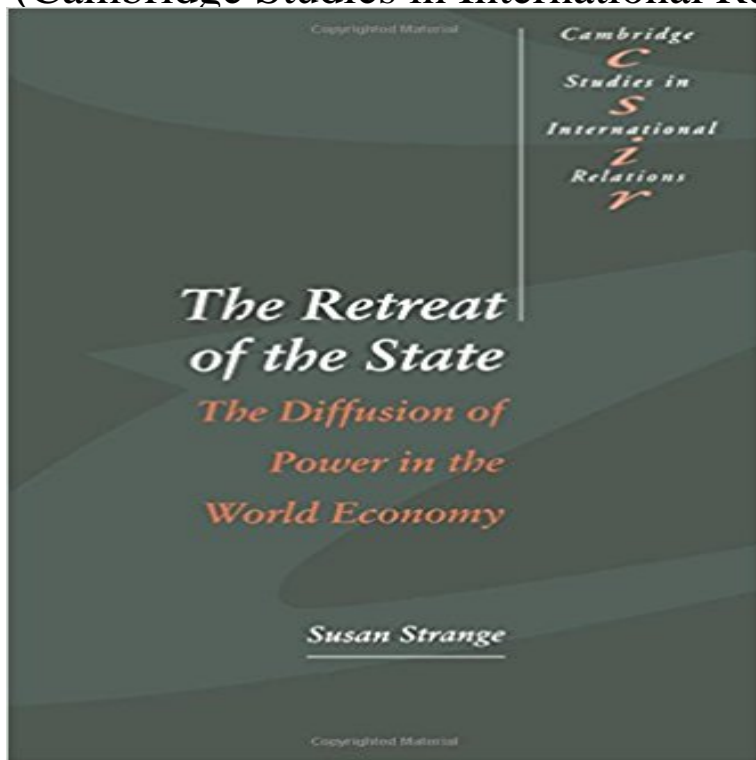


## The Retreat of the State: The Diffusion of Power in the World Economy (Cambridge Studies in International Relations)
