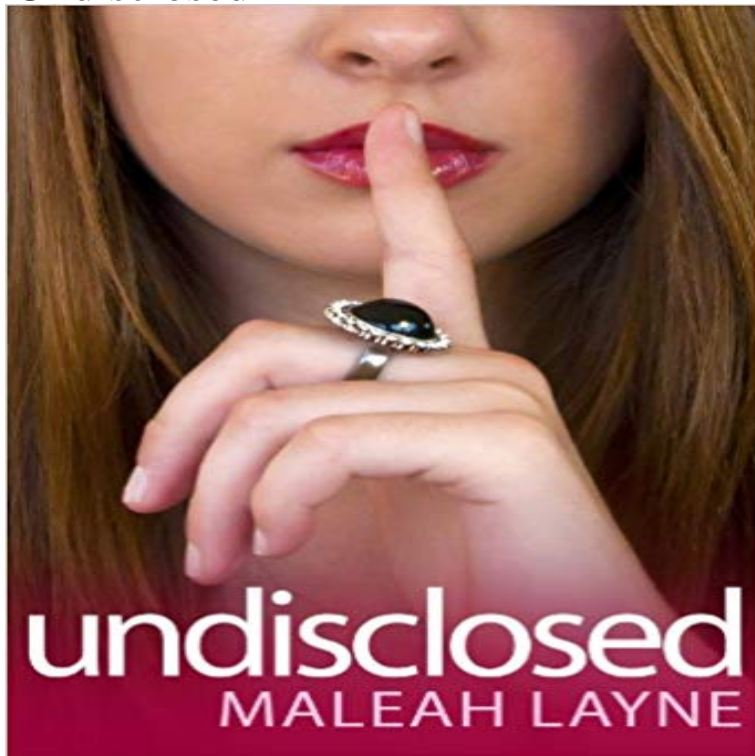


# Undisclosed
