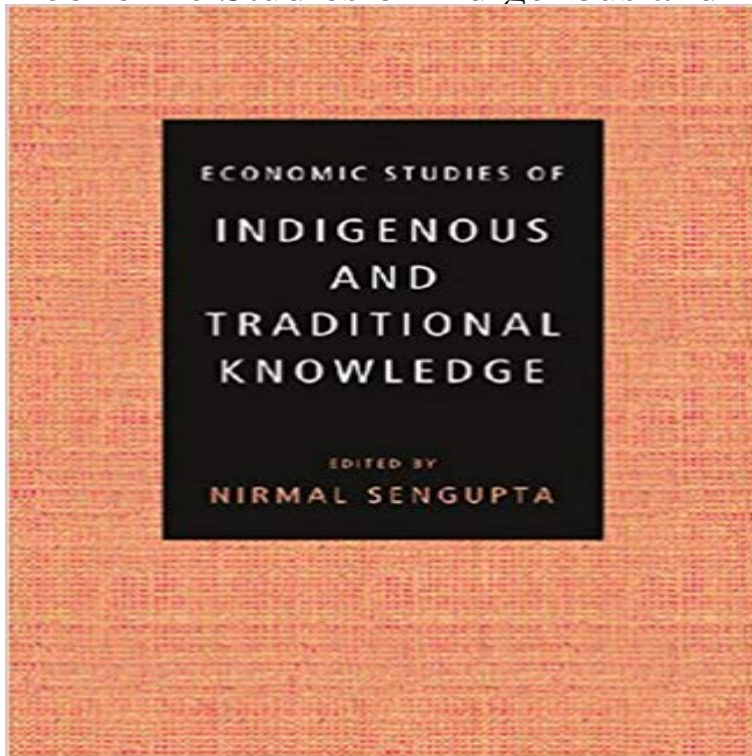


Economic Studies of Indigenous and Traditional Knowledge

Globally, indigenous knowledge is now recognized as an underutilized resource that can help to reduce poverty and a dormant reserve with considerable commercial potential.
