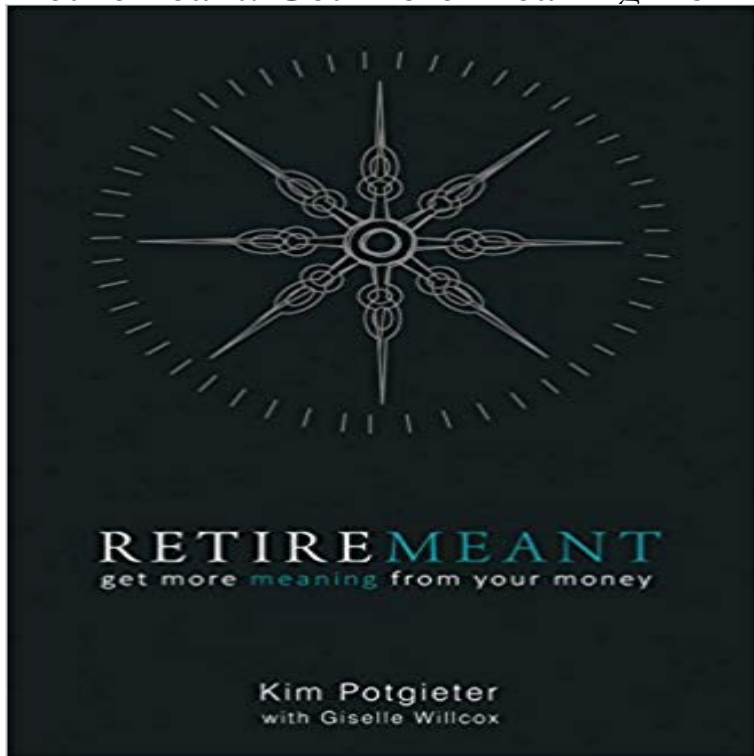


Retiremeant: Get More Meaning from Your Money
